Coal India is a government of India controlled coal mining company. It is the largest coal producer in the world with operations spread across 82 mining areas and 7 wholly owned subsidiaries. The company's performance had weakened in the recent past on account of stagnant e-auction share, cash accretion due to working capital release, higher cost in stock adjustment and higher provisions. Nonetheless, cash accretion is seen to be positive as it would release funds for potential usage and will also improve cash conversion cycle. Coal India has a benign outlook backed by demand uptick in power sector, supply under FSA and lower cost of production. E-action under FSA model gives higher realization to the company, which will help in improving the profit margins. Hence Buy.
