Fundamentally, crude is expected to trade lower as traders worried about negative economic news from the U.S. and China and signs of growing supply.

Key Levels: **98100 - 98400** (Support) and **99050 - 99350** (Resistance)



Fundamentally, gold is likely to trade higher buoyed by an overall weaker dollar, although signs of progress in trade negotiations between the U.S. and its trading partners kept gains in check.
