

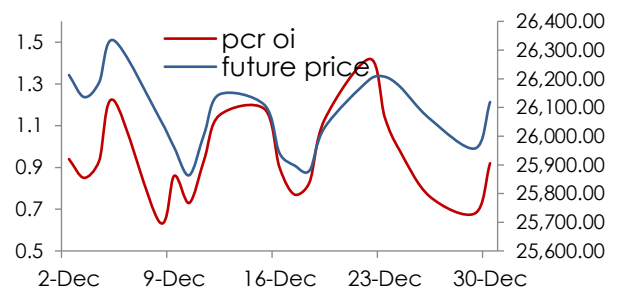
The November series largely remained a phase of consolidation, with the benchmark index oscillating within a narrow band of approximately 600–640 points. While the series will be remembered as a historic one, as key indices registered fresh record highs, it clearly lacked sustained momentum-based buying—especially when compared to the strong trend witnessed in commodity metals such as gold and silver. Ultimately, the final series of calendar year 2025 concluded with marginal gains, settling just below the 26,000 mark.

Rollover data for the series stood at 72%, lower than the three-month average, with negligible series-on-series change in open interest, indicating relatively lighter carry-forward positions into the January series. Bank Nifty rollovers came in at 77%, in line with its three-month average; however, this was accompanied by notable open interest unwinding, resulting in the new series commencing on a comparatively lighter OI base. On the flows front, Foreign Institutional Investors (FIIs) extended their selling streak for the sixth consecutive month, divesting equities worth ₹30,752 crore. In contrast, Domestic Institutional Investors (DIIs) continued to provide strong support, deploying ₹72,860 crore during the month. Meanwhile, the FII Long–Short Ratio in index futures remains in the oversold zone near 9%, highlighting the dominance of short positions by stronger hands. Looking ahead, the recent price action continues to favor a constructive undertone. Accordingly, our outlook remains positive, and we continue to recommend a Buy-on-Dips strategy for the near term.

NIFTY & PCR Graph



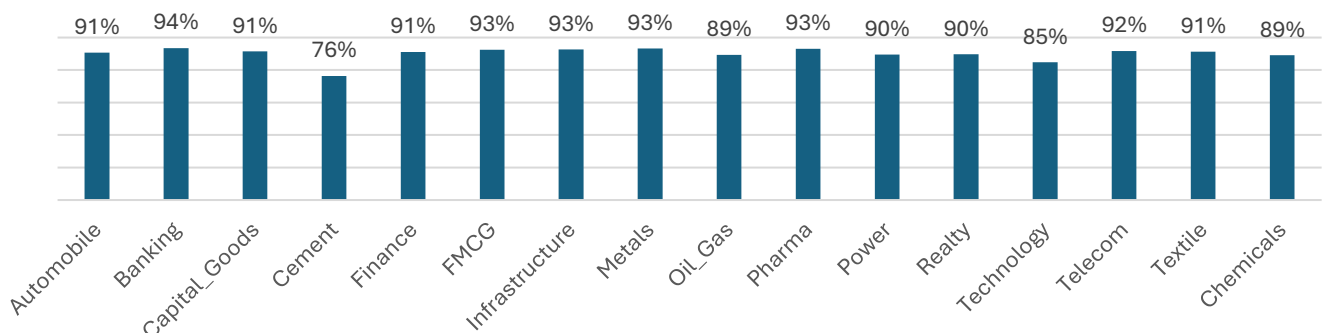
