


The Indian equity markets have witnessed a strong rebound since March, with the benchmark index extending its winning streak for the fourth consecutive month. Throughout most of the June series, Nifty traded within a well-defined range of 24500–25200, consolidating its prior gains. However, in the final session, strong buying interest emerged, propelling the index beyond this range and enabling it to reclaim the 25550 mark at the close. For the series, Nifty posted a healthy gain of 2.69%, reflecting sustained bullish sentiment and resilience despite intermittent consolidation phases.

Rollover data for the June series stood at 80%, comfortably above the three-month average, accompanied by a notable jump in outstanding contracts compared to the previous series. This points to traders carrying forward long positions into the new series, reflecting confidence in the ongoing uptrend. Notably, Foreign Institutional Investors (FIIs) have been consistently infusing liquidity for the fourth straight month, turning net buyers once again in June with purchases of ₹8,320 crore. At the same time, Domestic Institutional Investors (DIIs) continued their robust support, recording net purchases of ₹69,177 crore during the month. Another encouraging signal came from the Long-Short Ratio in index futures, which improved to 38% by the end of the series, indicating strengthening long-side participation. Given the market's recent resilience and sustained FII interest, sentiment remains constructive. Looking ahead, the 26000−26200 zone will act as a crucial resistance area, with a decisive breakout potentially propelling the index into uncharted territory. On the downside, the 25300−25200 zone serves as an immediate support level.

NIFTY & PCR Graph


